WHEREAS, the Agua Caliente Water Authority ("Authority") is an independent public agency established pursuant to the laws of the Agua Caliente Band of Cahuilla Indians, a federally recognized Indian tribe ("Tribe"); and

WHEREAS, pursuant to Section 7.12.060(a) of the Agua Caliente Tribal Code ("Tribal Code"), the Tribe has authorized the Agua Caliente Water Authority Board of Directors ("Board") to carry out the duties and powers of the Authority set forth in Chapter 7.12 of the Tribal Code; and

WHEREAS, Section 7.12.060(e)(6)(a) of the Tribal Code requires that the Board set all meeting dates, times, and places for its regular meetings by resolution; and

WHEREAS, the Board, pursuant to this Resolution, desires to set meeting dates, times, and places for the 2023 annual meeting and all regular meetings occurring within the 2023 calendar year.

NOW, THEREFORE, THE BOARD OF DIRECTORS OF THE AGUA CALIENTE WATER AUTHORITY DOES HEREBY RESOLVE AS FOLLOWS:

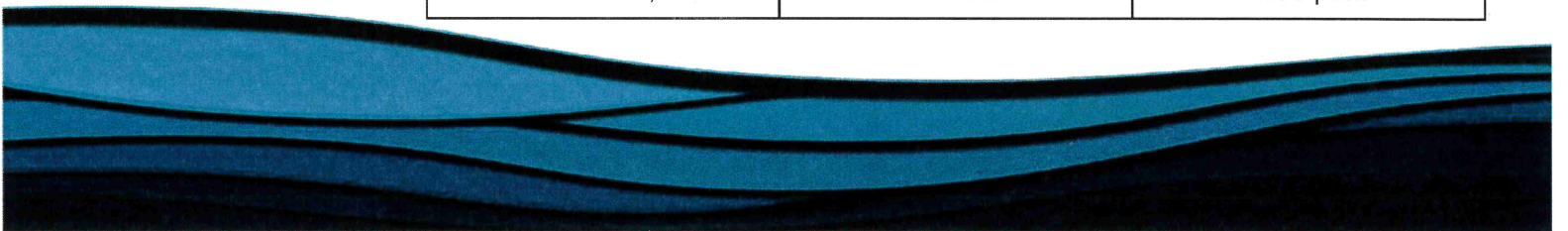
SECTION 1. The Board hereby establishes 1:00 p.m. as the start time for each regular meeting, which shall be held at a location on the Agua Caliente Indian Reservation; provided, closed sessions may be held prior to the start time for the open session portion of the regular meeting if the noticed agenda of the regular meeting indicates that such closed session will take place prior to the start time for the open session portion of the regular meeting.

SECTION 2. The Board hereby establishes the following meeting schedule for the 2023 calendar year, beginning with the February regular meeting:


